- a) The Principal of the RMPS INTERNATIONAL SCHOOL as Member, Secretary as per rule 20(2) (b) (i) of the C.B. S.E. Affiliation Bye Laws.
- b) Two parents to be nominated from the parent-Teachers Association by the Trust as per rule 20 (2) (b) (ii) of the C.B.S.E. Affiliation Bye Laws.
- c) Two Teachers of the OTHER School as Member to be nominator by the Trust as per rule 20 (2) (b) (iii) of the C.B.S.E. Affiliation Bye Laws.
- d) Two other persons (of whom one shall be woman) who are, or have been teachers of any other School or any College, to be nominated by the Advisory Board as per rule 20 (2) (b) (iv) of the C.B.S.E. Affiliation Bye Laws.
- e) Two members from out of a panel recommended by the Trust to be nominated by the Board. The names recommended should not below the rank of the Principal of a Senior Secondary School as per rule 20 (2) (b) (v) of the C.B.S.E. Affiliation Bye Laws.
- f) The remaining 03 members including the Chairman shall be nominated in accordance with the rules and regulations of the ShriAdeshwar Educational Trust.
